AFFIDAVIT OF GINA INTREPIDO-BOWDEN REGARDING OBJECTIONS AND REQUESTS FOR EXCLUSION

I, Gina Intrepido-Bowden, declare as follows:

I am a Vice President at JND Legal Administration ("JND"). This Affidavit 1. is based on my personal knowledge, as well as upon information provided to me by experienced JND employees and, if called upon to do so, I could and would testify competently thereto.

I previously submitted the Declaration of Gina Intrepido-Bowden re: Settlement Notice Program ("Intrepido-Bowden Decl.") filed April 9, 2024, ECF No. 303-2, the Declaration of Gina Intrepido-Bowen Regarding Settlement Notice Program Implementation ("Notice Decl.") filed July 5, 2024, ECF No. 365, the Supplemental Declaration of Gina Intrepido-Bowen Regarding Class Notice Implementation ("Supplemental Decl.") filed August 9, 2024, ECF No. 371-6, and the Declaration of Gina Intrepido-Bowen Regarding Compliance with the Class Action Fairness Act, 28 USC § 1715 ("CAFA Decl.") filed August 28, 2024, ECF No. 376.¹ JND is serving as the Settlement Administrator in the above-captioned litigation pursuant to the Court's Preliminary Approval Order filed May 1, 2024. ECF No. 325 at ¶ 9.

3. This Affidavit is being filed to notify the Court of objections and requests for exclusion per Paragraph 19 of the Preliminary Approval Order.

OBJECTIONS AND REQUESTS FOR EXCLUSION

4. The Direct Email, Direct Mail, and Publication Notices informed Class Members that anyone who wanted to exclude themselves from the Settlement could do so no later than **July 15, 2024**, and anyone who wanted to object to the Settlement could do so no later than **August 19, 2024**. The Long Form Notice provided explicit instructions regarding the process of objecting to the Settlement or requesting exclusion from the Settlement. The Direct Email and Publication Notices directed Class Members to the Settlement Website and the digital banner ads and the Publication Notice QR Code provided a link to the Settlement Website for details on how to object or request exclusion by mailing their written objections to the Court, Class Counsel, and Counsel for Defendants. The Settlement Website was updated continuously with all relevant filings in this action, including the Settlement, the motions for preliminary and final approval, the motion for fees, costs, and service awards, the Plan of Allocation and the motion for approval of it, relevant declarations in support of those motions, and Plaintiffs' Omnibus Response in Support of those motions.

5. As of September 3, 2024, JND has not received any objections to the Settlement, the Plan of Allocation, or Class Counsel's motion for fees, costs, and service awards.

6. As of September 3, 2024, JND has received 10 timely and valid exclusion requests and 6 invalid exclusion requests. JND notified all of those who submitted invalid exclusion requests and received 1 corrected exclusion request in response, resulting in a total of 11 timely and valid exclusion requests and 5 invalid exclusion requests. JND also received 1 timely and valid exclusion request that has since been withdrawn. Lists of the valid and invalid exclusion requests are attached hereto as **Exhibits A** and **B**, respectively. These lists are complete and accurate as of September 3, 2024.

CONCLUSION

7. JND is continuing to implement the Settlement pursuant to the Settlement Agreement and the Preliminary Approval Order.
